**CALL TO ORDER:** J Barg called the meeting to order at 7:00 p.m.

**PLEDGE OF ALLEGIANCE:** Pledge of Allegiance was recited.

**COMMENTS FROM VISITORS:**

Kim Lewis – asked the board if they would consider chloride on 57<sup>th</sup> Street.

Dean Johnson – asked the board when and how they will be trimming trees along 124<sup>th</sup> Street.

**ROAD MAINTENANCE:**

**Resignation** – Dave Johnson has resigned his position as grader operator. A motion by J Barg, seconded by M Breneman to accept Dave Johnson’s resignation with regret, and wish him the best in his future endeavors, carried unanimously.

Discussion was held regarding how to fill the position. Past grader operators were brought up as possible applicants. J Barg will contact some past operators to see if there would be an interest in applying. A motion by J Barg, seconded by M Breneman to place an ad in the Staples World for a part time road and snowplow operator, carried unanimously.

J Barg stated he has contacted Jason Keehr regarding a temporary grader operator position. Discussion followed. A motion by J Barg, seconded by M Breneman to hire Jason Keehr as grader operator until the position can be filled at \$25 per hour, carried unanimously.

**Traffic Counter** – M Breneman will contact Sylvan Township to see if May Township can borrow their traffic counters. If possible we will count traffic on 124<sup>th</sup>, 57<sup>th</sup>, and Red River Trail.

**Chloride** – Per the request by Kim Lewis the board discussed additional chloride on 57<sup>th</sup> Street. A motion by M Breneman, seconded by J Barg to add chloride from highway 210 to Blue Stem Road (46S – 33W) 7/8 mile – 1 mile, carried unanimously.

**124<sup>th</sup> Street** – Per Dean Johnson request the board discussed trimming, brushing, and cutting trees. They agreed to contact Dean and Jill Johnson when they begin trimming trees on 124<sup>th</sup> Street.

**ARPA GRANT:** Discussion was held on the ARPA grant. The board discussed uses for the money. No other action was taken.

**Parking Lot** - M Breneman will contact three paving companies to see what the cost of paving the parking lot is.

**ADJOURNMENT:** A motion by J Barg, seconded by M Breneman to adjourn meeting at 8:07 p.m. carried unanimously.
