May Township requires a headstone at each burial site within a 6 (six) month time frame following the burial.

- 1. Personal headstone: Minimum requirement - length should be 1' 4" to 2'6" long and width should be at least 8" to 1'4" wide; and/or
2. Family headstone: one (1) family headstone (per family) lot - base of headstone not to exceed five (5') feet in length or fourteen (14") inches in width. Overall height, base included, not to exceed forty-eight (48") inches in height. (Family headstone is not required, however, the above stipulations must be followed if you place a family headstone on the burial site.)

At the time of this application you must choose one of the following please read each option carefully:

OPTION 1: I am a family member of the deceased and am requesting a burial site in May Township at Bridgeman Cemetery. To this application I/we have attached a \$400 (refundable) fee for the purchase of a headstone (per burial site) by May Township. Please make check out to May Township. If mailing this form and check please send to: May Township, 5834 112th Street, Pillager, MN 56473. In the event a headstone is not placed on burial site within 6 (six) months of burial May Township will use these funds to purchase a headstone for the site. May Township will deposit your fee at the time of acceptance of this application. This fee will be refunded upon your family's compliance. Name of person & address for refund of fee:

OPTON 2: I am requesting a burial site for myself. I wish to be buried at Bridgeman Cemetery upon my death. I have pre-purchased a headstone for myself and/or family members. OPTION 3: I am requesting a burial site for myself. I wish to be buried at Bridgeman Cemetery upon my death. My family is aware they will have to submit a \$400 (refundable) fee to May Township before actual burial takes place.
