CALL TO ORDER: J Barg called the meeting to order at 7:02 p.m.

PROPANE 2023: Dooley's Petroleum Inc 2022-2023 residential propane pre-buy contract options. After discussion on costs of propane, amount of propane used last year, etc. the board made the following motion. <u>A motion by M</u> <u>Breneman, seconded by J Barg to approve the pre-buy price of \$2.04, one thousand gallons from Dooley's, carried</u> <u>unanimously.</u>

124th Street Discussion – M Breneman wanted to discuss the 124th Street project. The board heard from him regarding ditch slopping, thickness of tar needed for this road, and other questions regarding the readiness of this road to be tared at this time. Ditching needs to be done before this winter. Discussion followed. C Converse will talk with Cal Disterhaupt regarding ditching the road. If the costs are under \$5000, he has permission to continue. If not, then it will be brought back to the July 11 meeting.

108th Street Project – C Converse asked when the 108th Street project is slated to begin. J Barg stated he has spoken with Clint VanVickle, and there is no confirmed project start date. C Converse asked J Barg to contact the Minnesota Association of Townships lawyer and see if we can break this contract or add a completion date to it.

96th Street – <u>A motion by C Converse, seconded by M Breneman to approve the quote from Ideal Construction</u> <u>\$21800.00, 96th Street, carried unanimously</u>. Bids were opened at the June 13 2022 meeting. C Converse attended a meeting with Byron Township requesting their help with 96th Street. They discussed using fill for the project from their side of the town line road.

Miscellaneous – **Signs** - D Johnson is in the process of putting up the STOP signs. **Weed Grant** – J Barg will research the best use of the Weed Grant funds. More will be brought to the July meeting. **ARPA** – Uses for the ARPA monies was discussed. No action taken. **Ditch Mowing** - J Lund will start mowing the ditches after July 4 2022.

Comments from Visitors – K Lewis stated she likes the excel spreadsheet with the summer road projects. She would like to see the following added: prioritize the projects, estimated timelines for completion, and estimated costs. She also had questions on the townships processes. Discussion followed.
