**COMPENSATION AND WAGES**: Supervisors –<u>A motion by C Converse</u>, seconded by <u>M</u>
Breneman to set the board chairman wages at \$270 per month, the supervisors at \$220 per month and to pay \$50 per Park board, Motley fire department and Pillager Fire Department meeting, carried unanimously.

Clerk and Treasurer – A motion by C Converse, seconded by M Breneman set the Treasurer wages at \$350 per month, carried unanimously. A motion by M Breneman, seconded by J Barg to set the Clerk's wages at \$440 per month, carried unanimously. C Converse asked the clerk and treasurer to keep track of their time and report to the board.

Dave Johnson - A motion by C Converse, seconded by M Breneman to set the 2023 wages for May Township grader operator - Dave Johnson at \$27.00 per hour, carried unanimously.

A motion by C Converse, seconded by M Breneman to compensate township operators' two-hours wage for attending regular township meetings, carried unanimously.

Second Operator – A motion by C Converse, seconded by J Barg to set the pay for supervisor work on township roads at \$27 per hour when using the grader, truck, etc., carried unanimously.

Temporary Grader Operator – <u>A motion by C Converse</u>, seconded by J Barg to set the temporary grader operator wages at \$20 per hour, carried unanimously.

General Labor - <u>A motion by J Barg, seconded by M Breneman to set the general labor wages at \$20.00 per hour, carried unanimously.</u>

Election Judge – <u>A motion by C Converse</u>, seconded by J Barg to set the 2023 election judge wages at \$15 per hour, carried unanimously.

**RESOLUTIONS**: B Wyffels presented a copy of **all** resolutions approved during the past years. The board was asked to review. A motion by J Barg, seconded by M Breneman to approve the resolutions as presented for 2023, carried unanimously.
