**COMPENSATION AND WAGES**: **Supervisors** –A motion by J Barg, seconded by C Converse to set the board chairman wages at \$280.00 per month, the supervisors at \$230.00 per month and to pay \$50.00 per Park board, Motley fire department and Pillager Fire Department meeting, carried unanimously.

Second Operator – <u>A motion by C Converse</u>, seconded by <u>M Breneman to set the pay for supervisor work on township roads at **\$27.00** per hour when using the grader, truck, etc., carried unanimously.</u>

Temporary Grader Operator and Truck Driver – <u>A motion by M Breneman, seconded by C Converse to set the temporary grader operator and truck driver wages at \$25.00 per hour, carried unanimously.</u>

General Labor - <u>A motion by C Converse</u>, seconded by <u>M Breneman to set the general labor wages at **\$22.00** per hour, carried unanimously.</u>

Election Judge – A motion by M Breneman, seconded by J Barg to set the 2024 election judge wages at \$17.00 per hour unanimously.

**RESOLUTIONS**: B Wyffels presented a copy of **all** resolutions approved during the past years. The board was asked to review. A motion by M Breneman, seconded by C Converse to approve the resolutions as presented for 2024, carried unanimously.
